

March 26 Board Meeting

Vice President called the meeting to order at 6:30PM

Reminder: President, Vice President, Treasurer are up for election at the end of the year, if you're interested please reach out.

Treasurer:

- 65,518.36 is what is in our account as of today.
- Everything is paid and up to date.

Football:

- The NKYFL meeting last month covered bylaws.

- The proposal mentioned at this meeting was that D1 would consist of 7 teams, D2 would consist of all other teams.
